Hand-Delivery: Completed ballots can be dropped at the SLVHA Office during normal working hours and placed in the locked Ballot Box for the Inspector of Elections no later than 10:00 a.m. on February 6, 2025. Alternatively, members can hand deliver ballots directly to the Inspector of Elections between the hours of 9:30 a.m. and 10:00 am. on February 6, 2025, at the Community Center Auditorium.

Candidate Statements, Ballot Envelopes and Voting Instructions on how to complete and return ballots will be provided with the Official Ballots.
